





# - RDA ? -

**Resource Description and Access (RDA)** is a standard for descriptive cataloguing initially released in June 2010, providing instructions and guidelines on formulating bibliographic data. Intended for use by libraries and related cultural organizations such as museums and archives, **RDA is the successor to Anglo-American Cataloguing Rules, Second Edition (AACR2)**, the prevailing standard for English language libraries since 1978.

Untuk bergerak seiring dengan lain-lain perpustakaan, khususnya sebagai sebuah pusat sumber perkongsian maklumat bibliografi, Perpustakaan UTM juga perlu menerima dan melaksanakan perubahan penstrukturkan semula kemasukkan data di dalam rekod bibliografi secara terbuka.
