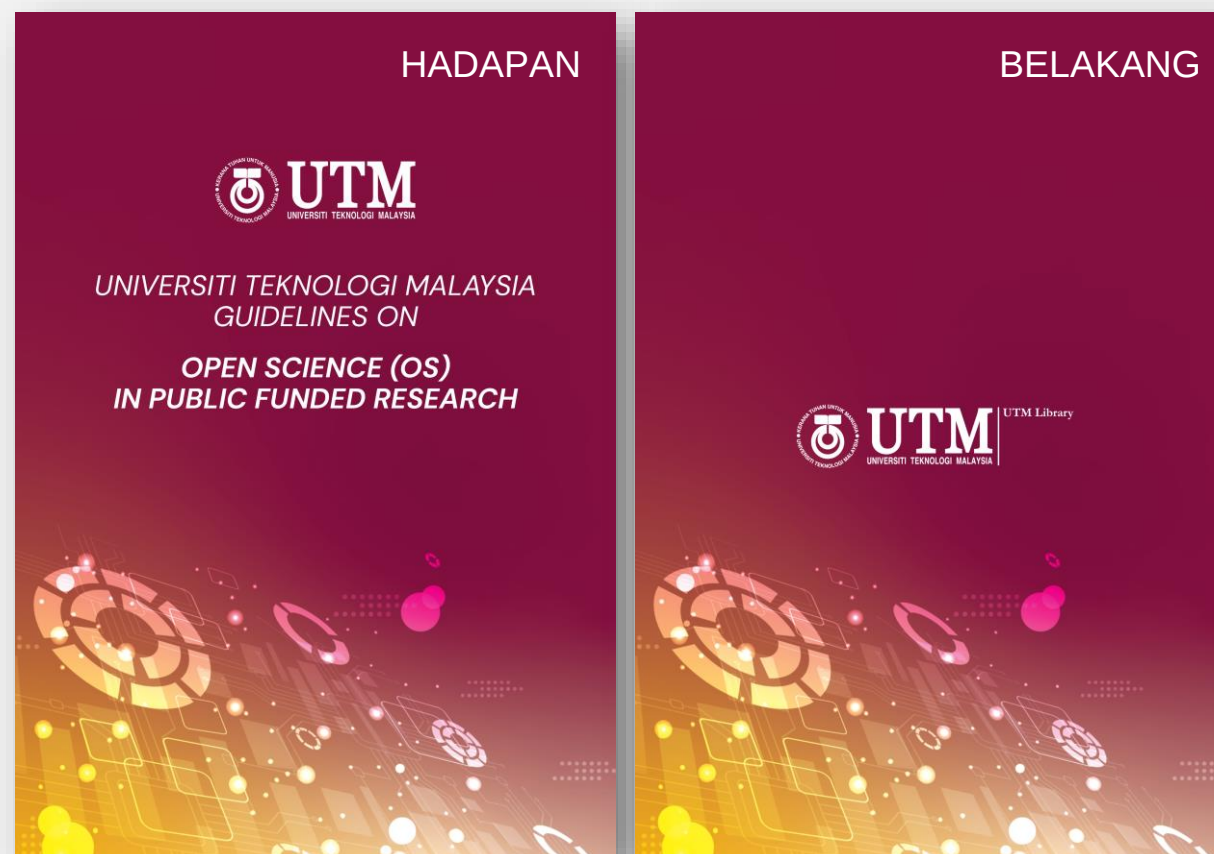

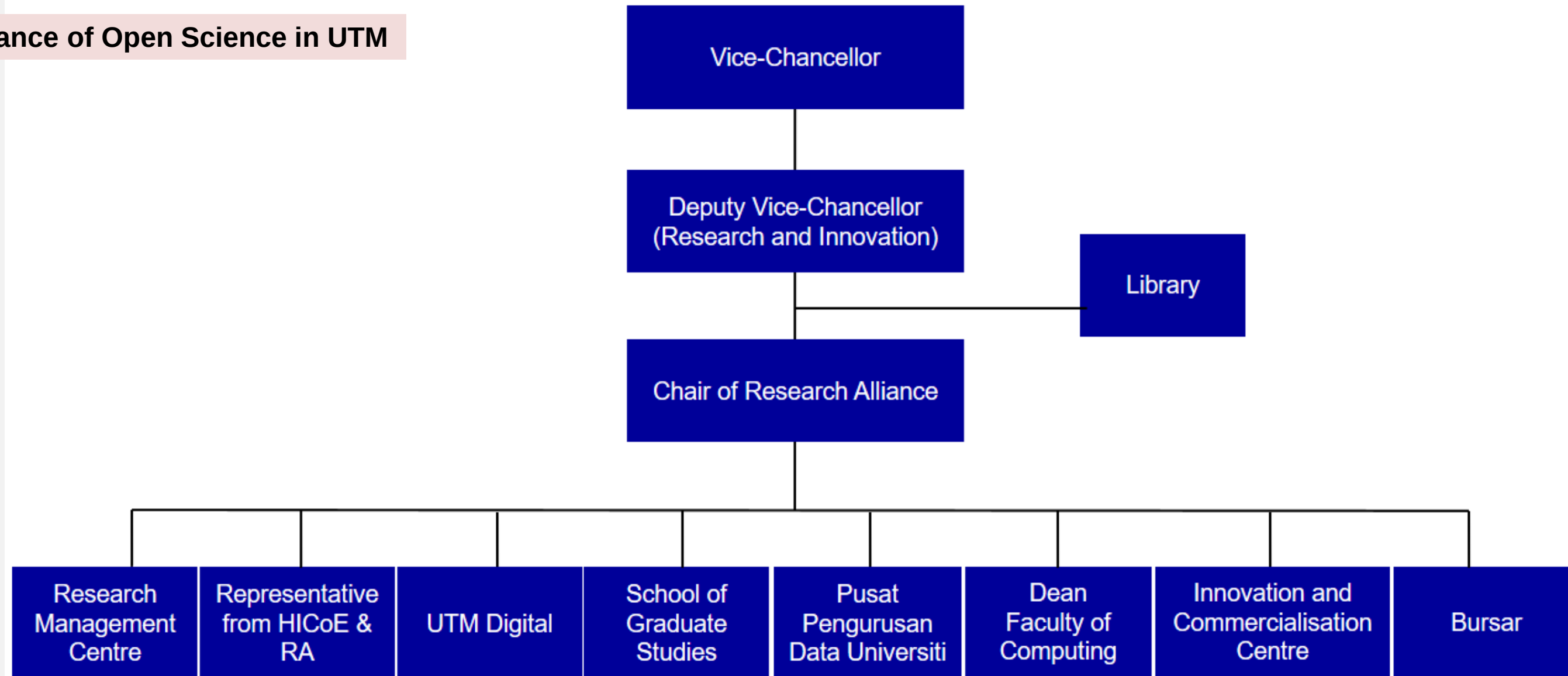

#### 1. Latar Belakang

Sains Terbuka menggalakkan ketelusan, kebolehcapaian, perkongsian dan kerjasama dalam penyelidikan. Selaras dengan inisiatif di peringkat kebangsaan dan antarabangsa, UTM komited untuk mewujudkan persekitaran penyelidikan yang menyokong amalan Sains Terbuka secara menyeluruh. Penubuhan jawatankuasa ini adalah penting bagi membangunkan garis panduan yang komprehensif sebagai kerangka pelaksanaan Sains Terbuka di peringkat universiti.

#### 2. Objektif
